





Academic Interests:

My academic interests focus on understanding the changing dynamics of global decentralization, particularly as it affects institutions of local government and the governing of metropolitan regions. I am focused on two dimensions of this research. The first involves structural issues around which governing decisions are made. Topics in this area include regional organizing of local governments and institutions that are extensions of those local governments. The second area involves variations in political culture or shared community understandings of how the socio-political world is “supposed to operate”. These regional variations in norms and values play an important role in framing the debate and discussion on the structural issues previously mentioned.
