






Please find the attached resume of Stella Massey, whom I am recommending for appointment to the Area Agency on Aging Advisory Council ("Advisory Council").

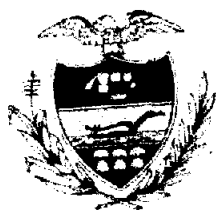
