


Please find the attached resume of Jack Wise, whom I am recommending for reappointment to the Redevelopment Authority of Allegheny County Board ("RAAC Board").



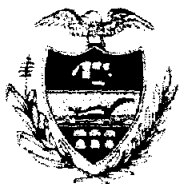

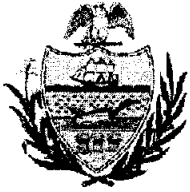
