**Summary:** *This Ordinance would authorize the use of County owed real property by Voice Stream Pittsburgh for the purpose of placing a cellular antenna on top of the County Office Building.*

*Director Donatelli said over \$1 million dollars of revenue would come from Voice Stream, by placing a cellular antenna on top of the County Office Building. He said Voice Stream has a relationship with T-Mobile.*

*Director Donatelli said the money would go into the General Fund.*

*Councilman Burn said that this was done in Millvale and called it a win-win situation. He said it increased profitability over time and there's no drawback to doing this.*

*Councilman Finnerty asked whether there was any expense to the County. Director Donatelli said no, there is no cost, and Voice Stream does the maintenance. The County just gives them the space. He said our rates are superior to others.*
