


Please find the attached resume of Peter Czuczman, whom I am recommending for reappointment to the Authority for the Improvements in Municipalities.

This Authority provides low interest loans to municipal governments and authorities to help them finance various capital needs including infrastructure, equipment and buildings. Grants are available for projects that are multi-municipal in nature, or impact a county facility. AIM also has the ability to issue tax-exempt financing, administer the distribution and investment of fiduciary funds, and provide deferred loans for special project activities. I am recommending that Mr. Czuczman serve another 5-year term, which will expire on December 31, 2013.

Mr. Czuczman attended the University of Pittsburgh with a major in Business Administration. His career includes working with the Redevelopment Authority of Allegheny County, the Allegheny County Housing Authority and also self-employed as an insurance broker.
