Timothy H. Johnson is a versatile executive who has performed for the past twenty-five years at the highest levels of corporate, government and non-profit leadership. Tim is skilled at defining strategic goals and executing objectives and has extensive experience in finance, administration, diversity and organizational change.

In 2004, Tim was appointed Director of Administrative Services by County Executive Dan Onorato, becoming the first African American Super-Director of a department in Allegheny County history. In this capacity he leads a staff of 400 and manages a \$28 million budget, encompassing numerous divisions that include Property Assessment, Computer Services, Elections, Purchasing and nine others.

Prior to his current position, Tim was CEO and Managing Partner of the Horizon Management Group and Mezzanine Fund which is a consulting company and an investment firm, respectively.

As Vice President of National City Bank of PA, he reversed community protest by bringing diverse groups together, resulting in three bank mergers which benefitted shareholders and the community alike. Tim then proceeded to establish an award-winning lending organization, recognized by the Small Business Administration as the top-producing lender in Western Pennsylvania for eight consecutive years.

Other professional experience includes: Urban League of Pittsburgh Inc. (Vice President Finance and Development), Ketchum Incorporated (Capital Campaign Director) and ALCOA (Sales Representative).

Tim graduated from Duquesne University with a Bachelor of Science in Business Administration and earned a Master of Science in Organizational Behavior from Robert Morris University. Additionally, he is trained in Six Sigma and has studied International Business at Tecnologico De Monterrey in Cuernavaca, Mexico.

Tim is an advisor to the Robert Morris University School of Adult and Continuing Education; and RMU Diversity Committee; member of the University of Pittsburgh, Institute of Politics, Fiscal Policy & Governance Committee; member of the Pittsburgh Symphony Orchestra's Audience Development Committee; and Trustee for Allegheny County's \$750 million pension fund. He also serves on the boards of Gilda's Club of Western PA, Communities in Schools, Allegheny County M/W/DBE Advisory Committee, Pittsburgh Allegheny County Thermal and the Greater Pittsburgh DiverseCITY Festival.

Tim is the son of Mrs. Irma Johnson-Cauley of Beltzhoover. Recently married, Tim resides in Mt. Lebanon with his wife Atiya and is the father of Jason and Juliet. Tim is a Deacon at Triumph Baptist Church where he is Chairman of the "Proceeding with the Promise" Capital Campaign Committee.
