





Dear Council Members:

Please find the attached resume of Jacques L. Moye, Sr., whom I am recommending for appointment to the Allegheny County Residential Finance Authority.

The Residential Finance Authority has the ability to issue obligations for any eligible project within the Commonwealth, provided it receives by resolution, host approval from the highest elected official of the city or county in which the project is located. The Authority issues obligations on behalf certain developers for the financing and/or refinancing of costs incurred for the acquisition, reconstruction, rehabilitation, renovation or improvement of a project. Mr. Moye will fill a vacancy on the Residential Finance Authority. His term will end on December 31, 2007.

Mr. Moye is a CPA who formerly worked for Deloitte and Touche, LLP. Following his employment with Deloitte, Mr. Moye joined the staff of the Allegheny County Controller's Office as a Chief Financial Analyst. In January 2004, Mr. Moye transitioned to the Chief Executive's Office, and currently serves as an Administrative Assistant.
