





James M. Flynn Jr. has served as the Allegheny County Manager since January 2004. As the County Manager, he is the chief administrative officer of the county and is responsible for the administration of the county's operations. He previously served as the Deputy Controller of Allegheny County. In addition, he has over 17 years of experience in the private sector, serving both as a controller and senior accountant.

Mr. Flynn earned a B.S. from Carnegie Mellon University in public policy and management, as well as a B.S. from Point Park College in accounting. He has passed the Certified Public Accounting Examination and earned a M.B.A. from Robert Morris University.

He currently sits on the board of directors of Allegheny Correctional Health Services which is the firm that provides the medical services at the Allegheny County Jail.
