

Dear Council Members:

Please find the attached resume of Janice Palmer, whom I am recommending for appointment to the Agricultural Land Preservation Board.

The purpose of the Agricultural Land Preservation Board is to purchase the development rights of undeveloped farm land in Allegheny County. These development rights are held as easements against the property, meaning that the land cannot be developed. This board was created by state law and its activities are funded by the State. I am recommending that Ms. Palmer serve a 3-year term ending on December 31, 2010. Ms. Palmer will replace Sue Caffrey, whose term expired at the end of 2007.

Ms. Palmer will serve as the municipal elected official representative on the Agricultural Land Preservation Board, as she is a member of Green Tree Borough Council. She currently serves a Public Safety Committee Chair, and is the past Chair of the Public Properties Committee.

I appreciate your consideration, and ask you to act on this appointment as quickly as possible. Ms. Palmer will make herself available for review before the appropriate committee if members of Council wish to speak with her.
