***Section 4.*** *Any Resolution or Ordinance or part thereof conflicting with the provisions of this Resolution is hereby repealed so far as the same affects this Resolution.*

**PROJECT DESCRIPTION / NECESSITY**

This is grant funding from the City of Pittsburgh to assist local child care agencies with program upgrades, curriculum materials, professional development and facility improvements needed to improve early learning resources centers. The funding will assist local child care agencies in attaining the "high-quality" designation from the Commonwealth of Pennsylvania, based on Pennsylvania's Quality Rating and Improvement System Keystone STARS. High-quality facilities provide a stimulating, safe and nurturing environment for children, which prepares them for school and to reach their full potential. Allegheny County Department of Human Services will administer the Child Care Quality Fund on behalf of the City of Pittsburgh.
