Ms. Eisenreich works on special projects, does strategic planning and development as well as developing networks for clients. Current clients include Manchester Bidwell Corporation, Forbes Fund, and the United Way.

Ms. Eisenreich was appointed to this position by Governor Tom Corbett in February, 2011.
