

Dear Council Members:

Please find the attached resume of Joe Natoli, whom I am recommending for reappointment to the Parks and Recreation Commission of Allegheny County.

The commission is intended to augment the policy-making powers of the Chief Executive and County Council in improving the parks, not replace them. The commission is a county agency as defined in the Administrative Code and is subject to all provisions within the code relating to agencies. I am recommending Mr. Natoli to serve another 4 year term ending on December 31, 2009.

Mr. Natoli retired in 1998 as the Director of Parks and Recreation of Allegheny County, a post he also held from the period of 1986-1996. Prior to that position, Mr. Natoli served as Assistant Director of Parks and Recreation for the City of Pittsburgh for 36 years.

I appreciate your consideration, and ask you to act on this appointment as quickly as possible. Mr. Natoli will make himself available for review before the appropriate committee if members of Council wish to speak with him.

Joe Natoli's public service has spanned for almost half a century. Mr. Natoli is responsible for creating the Morningside Bulldogs in 1949. He coached the team from 1949-1979 in which the Bulldogs were recognized as the most successful pre-high school football team in America. Mr. Natoli began in 1950 as a laborer with the City of Pittsburgh Department of Parks & Recreation. From that point, he was on pace to become the Department's Assistant Director for the next 36 years. Mr. Natoli achieved great accomplishments for Pittsburgh that in turn led him to be named Director of Parks and Recreation for the County of Allegheny from 1986-1996 and then in 1996-1998. In between those years he headed the Allegheny County Department of Veteran Services. Mr. Natoli's dedication to public service has not gone unnoticed. He received several honors and awards such as: Dapper Dan, Ideal Citizen, Morningside Man of the Year, National Italian American Sports Hall of Fame, Western Pennsylvania Hall of Fame and the naming of Joe Natoli Field and Recreation Center.
