



Please find the attached resume of James E. Barrick, whom I am recommending for reappointment to the Air Pollution Control Advisory Committee.

The Air Pollution Control Advisory Committee currently operates under Section 2101.07 of Article XXI of the Allegheny County Health Department. The Committee recommends to the Board of Health additions and changes to the rules and regulations, and advises the Department and Board of Health on matters relative to the control of air quality in Allegheny County.
