


Please find the attached resume of William F. Sray, whom I am recommending for appointment to the Agricultural Land Preservation Board.

The purpose of the Agricultural Land Preservation Board is to purchase the development rights of undeveloped farm land in Allegheny County. These development rights are held as easements against the property, meaning that the land cannot be developed. This board was created by state law and its activities are funded by the State. I am recommending that Mr. Sray fill the unexpired term of Ron Beinlich, who has resigned from the Board, ending on December 31, 2010.

Mr. Sray was born and raised on a family farm in Allegheny County. He currently operates a farm enrolled in the Allegheny County Agricultural Land Preservation Program, and has a second farm pending acceptance. Mr. Sray raises registered Black Angus cattle, and also is involved in an aggressive hay growing/bailing operation.

I appreciate your consideration, and ask you to act on this appointment as quickly as possible. Mr. Sray will make himself available for review before the appropriate committee if members of Council wish to speak with him.

Attached please find my application for the vacancy on the Allegheny County Agricultural Land Preservation Board.

I was born and raised on my family's farm here in Allegheny County. After graduating from Penn State University with a Bachelor of Science degree in Agricultural Science and Industry, I moved to New Jersey. I am a veteran of the U.S. Air Force, having served during the Viet Nam war era. After an honorable discharge I went on to own and operate the Sray Funeral Home for 40 years. While there I was elected to political office, serving as Township Committeeman, Township Clerk, Vice-Mayor and Mayor of Upper Deerfield Township, Cumberland County, for some 33 years.

I also served as an active member on the Township Planning Board, Zoning Board of Adjustments, and the Historical Commission. It was primarily a farming community so I had lots of opportunities during those years to observe firsthand how the New Jersey Farmland Preservation Program operated.

I was President and Secretary of the Overlook Cemetery Association, having also served as its Manager.

After retiring in 2002, my wife and I moved back to the Pittsburgh area where we purchased several farms next to my parent's original farm, one of which is already registered in the Allegheny County Agricultural Land Preservation Program. A second farm is pending acceptance. At present I am raising registered Black Angus cattle and am also involved in an aggressive hay growing/baling operation.

I wholeheartedly approve the Farmland Preservation Program and would very much like to be a part of its future.
