



Dear Council Members:

Please find the attached resume of Paul Quarantillo, whom I am recommending for reappointment to the Redevelopment Authority of Allegheny County Board of Directors ("RAAC Board").

The purpose of the RAAC Board is to implement economic development programs and carry out housing rehabilitation and development. Pending confirmation, Mr. Quarantillo will serve an additional five-year term, ending on December 23, 2007.
