#### **Committee on Budget and Finance - Second Reading**

This resolution authorizes the amendment of the 2018 Grants & Speical Accounts Budgets to accomodate two newly awarded grants (one to support re-accreditation efforts in the Office of the Medical Examiner and one to provide training relating to opioid response to the local Medical Reserve Courps units), and an increase in the awarded amount in two existing grants (one to aid in reducing mosquito-borne illness and one to provide additional tools for court personnel to better address the opioid epidemic). None of the amendments requires the County to provide matching funds.

#### Committee on Economic Development & Housing - Second Reading

<u>10530-18</u> A Resolution approving a Project for the benefit of Duquesne University of the Holy Spirit, a nonprofit corporation organized under the laws of the Commonwealth of Pennsylvania (the "University"), to be financed by the

Allegheny County Higher Education Building Authority by the issuance of the Authority's federally taxable and/or tax-exempt bonds or notes, to be issued in one or more series, in the aggregate principal amount which, together with original issue premium and less original issue discount, is not expected to exceed \$20,000,000, provided that the taxing power of the County of Allegheny, Pennsylvania (the "County"), shall not be obligated in any way with respect to the Bonds (hereinafter defined), and determining that the purpose of the financing will be to benefit the health and welfare of the citizens of Allegheny County, Pennsylvania.

This resolution declares that it is beneficial to the health, safety and welfare of the County's residents to finance the project described in the bill through the issuance of up to \$20 million in bonds by the Allegheny County Higher Education Building Authority.
