

Dear Council Members:

Please find the attached resume of Mr. Thomas Headley whom I am recommending for reappointment to the Allegheny County Agricultural Preservation Board. Mr. Headley's term will expire on December 31, 2007.

The purpose of the Preservation Board is to purchase the development rights of undeveloped farm land in Allegheny County. Development rights are held as easements against the property to preserve the land and prevent it from being developed. The Board was created by State law (ACT 149 of 1988) and funded by the Commonwealth of Pennsylvania.

Mr. Headley has a varied background in both public service and private industry. He currently serves as President of The Twin Rivers Council of Governments, an association of 14 communities in the Mon Valley. In addition, Mr. Headley is Chairman of the Twin Rivers Regional Planning Committee, a group responsible for the development of a new Regional Plan for the Twin Rivers COG communities. He serves as Vice-chairman of the Forward Township Board of Supervisors.

I appreciate your consideration and ask you to act on this appointment as quickly as possible. Mr. Headley will make himself available for review before the full Council or the appropriate committee if members of Council wish to speak with him.
