Dear Members of Council:

Please find the attached resume of John L. Tague, whom I am recommending for reappointment to the Allegheny County Port Authority pursuant to Pennsylvania Act 72 of 2013.

The general purpose of the Port Authority is to operate an integrated transportation system for the purpose of moving large numbers of people safely, efficiently and economically. Today, Port Authority provides about 70 million rides annually and operates a fleet of 1,000 buses, 83 light rail vehicles and two inclined planes while also offering ACCESS paratransit service. I am recommending Mr. Tague serve a 4-year term, which will expire on September 17, 2019. He was originally recommended by the Committee for Accessible Transportation.
