XI. New Business - Ordinances & Resolutions

An ordinance of the County of Allegheny, Commonwealth of Pennsylvania amending and supplementing the Allegheny County Code of Ordinances, Division 5, entitled "Health and Sanitation," by the creation of a new Chapter 525, entitled "Single Use Plastics" in order to establish a prohibition on the distribution of certain single use plastic bags within Allegheny County.

A Resolution of the County of Allegheny, Commonwealth of Pennsylvania condemning the unprovoked terrorist attack launched by Hamas against the State of Israel on October 7, 2023, supporting justice and safety for the Israeli and Palestinian people, and expressing deep condolences to the families of those who have lost their lives as a result of this senseless act of violence.

A Resolution approving a project for the benefit of Duquesne University of the Holy

Spirit, a Pennsylvania non-profit corporation (the "**University**"), to be financed by the Allegheny County Higher Education Building Authority (the "**Authority**") by the issuance of the Authority's taxable and/or tax-exempt revenue bonds, in one or more series, in an aggregate principal amount not to exceed \$35,000,000 (the "**Bonds**"), provided that the taxing power of the County of Allegheny, Pennsylvania (the "**County**") shall not be obligated in any way with respect to the Bonds, and declaring the financing of such project as desirable for the health, safety, and welfare of the people in the County.
