The Chair called Mr. Wright to the table, and he provided a summary of the project to be undertaken and the need for right of way acquisition. Mr. Wright noted that the situation involves a small amount of property, but that a large number of heirs own fractional

shares of that property and difficulty in locating all of those heirs may require a taking.

In response to a question from Ms. Heidelbaugh, Mr. Wright noted that those heirs that have been reached wold be willing to sell the property to the County, but that not all can be reached.

In resposne to a question from Ms. Means, Mr. Wright indicated that he would obtain information delineating which of the heirs have been contacted and which are unavailable.
