In response to a question from Ms. Danko, Mr. McKain indicated that this funding source had not been anticipated at the time that the capital budget was formulated, so it is not known at this time exactly what projects may be funded by this appropriation.

In response to a question from Ms. Means, Mr. McKain described how potential bridge projects will be prioritized.

The Chair noted that this appropriation does increase the aggregate amount of the capital budget, but that no additional bond funding would be utilized.
