#### IV. Agenda Items

### **Appointments**

Approving the reappointment of Robert J. Lewis to serve as a member of the Allegheny County Airport Authority for a term to expire on December 31, 2020.

**Sponsors:** Chief Executive

Mr. Lewis discussed the hiring of Christina Cassotis as the new Chief Executive Officer and her ability to grow business at the airport. Mr. Lewis explained the vision and challenges for Pittsburgh International to become an origin and destination airport. Mr. Lewis commented on the importance of the airport's branding identity, the possibility of installing slot machines at the airport, opening the Airmall to the public, and finding other ways to increase revenue. Councilman Walton commented on the significance of increasing passenger traffic. Mr. Lewis reported that the Newark Liberty International Airport in Newark, New Jersey serves the catchment area (i.e. New York) and that is why it is so successful, however, for Allegheny County, increasing passenger traffic will continue to be a challenge. Councilman DeMarco mentioned diverting flights to Pittsburgh, and Mr. Lewis replied that this occurs now. Mr. Lewis told Councilwoman Means that he was first appointed when the Authority was established. In response to a question from Councilwoman Means, Mr. Lewis stated that as a result of 9/11 and increased security measures it would be difficult to take your kids out to watch the airplanes as was frequently done in the past, however, he imagined that they could conduct an educational aviation program to benefit students.

A motion was made by Finnerty, seconded by Walton, that this matter be Affirmatively Recommended. The motion carried by a unanimous vote.
