III. Approval of Minutes

IV. Agenda Items

Ordinances

- An Ordinance authorizing the County of Allegheny to convey a 25-foot wide easement a distance of approximately 6,650 feet to Duquesne Light Company, having its principal office at 411 Seventh Avenue, Pittsburgh, PA 15219, for the purposes of installing and maintaining two parallel underground electric power transmission lines in Boyce Park, tax parcel No. 975-L-380, on and along Centerview Drive and Deever Road between Center (Monroeville-Trestle) Road and New Texas Road, situate in Plum Borough, for a fair market value of \$60,000.00.
 - <u>Sponsors:</u> Chief Executive

Mr. Macey chaired the meeting in the absence of Chairman Palmiere.

At Mr. Macey's request, the clerk read the title of the bill and Mr. McKain summarized its

provisions, noting that the new electric lines will enhance Duquesne Light's ability to provide service to residents of the Plum Borough area.

In response to questions from Mr. Macey, Mr. Meritt noted that the transmission line would carry 138,000 volts, and that the service enhancement would directly impact roughly 30,000 households.

In response to a question from Ms. Means, Mr. Meritt noted that the portion of the lines that run through Boyce Park would be entirely underground.

Mr. Finnerty asked about land clearance, and *Mr.* Meritt indicated that the lines would follow the existing roads within the Park, with a trench to be excavated along the road. *Mr.* Meritt noted that the excavation should impact very few trees, and *Mr.* McKain and *Mr.* Varhola indicated that the placement of the line was specifically chosen to minimize impact upon trees.

In response to a question from Mr. Macey, Ms. Antanis indicated that the entire path through the park would be underground, with access provided through manholes anticipated to lie within the roadway. Mr. Meritt noted that the final design from the project was not yet completed, and that terrain would to some extent dictate manhole placement.

A motion was made by Finnerty, seconded by Macey, that this matter be Affirmatively Recommended. The motion carried by a unanimous vote.

V. Adjournment

The meeting was adjourned at 4:11.
