Ms. Sewell told members that she was appointed to the committee three years ago and led the effort to improve operations of the County's M/W/DBE Program through the establishment of a new Chapter 435 in the County Code of Ordinances. Ms. Sewell and Councilman DeMarco discussed her background in sales with J&L Specialty Steel and operating The LJS Group, a small business. Ms. Sewell discussed her continuing interest in expanding opportunities for minorities within the region.

Ms. Ogoreuc and Chairman Kress discussed the important connection between public transportation and economic development. Ms. Ogoreuc and members discussed bus rapid transit (BRT), RideACTA, and transit-oriented development (TOD) in Allegheny County. Councilman DeMarco remarked that some constituents feel their bus service is inadequate. Ms. Ogoreuc responded, stating that the Port Authority, while restricted in some ways, can extend existing routes. She added that they are examining the service data and in a planning phase. Ms. Ogoreuc explained transit-oriented development and agreed to provide Councilwoman Means with a copy of the Port Authority's Transit-Oriented Development Guidelines.
