A Resolution of the County of Allegheny amending the 2013 Capital Budget for Allegheny County.

**Whereas**, the County has adopted a Capital Budget for the fiscal year beginning January 1, 2013 and ending December 31, 2013; and

**Whereas**, at the request of the County's Department of Budget and Finance, County Council desires to amend the 2013 Capital Budget as set forth in Attachment "A;" and

**Whereas**, the 2013 Capital Budget will remain in balance if the amendments set forth in Attachment "A" are approved.

## The Council of the County of Allegheny hereby resolves as follows:

### SECTION 1. <u>Incorporation of Preamble.</u>

The provisions set forth in the preamble to this Resolution are incorporated by reference in their entity herein.

### SECTION 2. <u>Approval of Capital Budget Amendment.</u>

The County Council of Allegheny County hereby authorizes the amendment of the Allegheny County 2013 Capital Budget as set forth in Attachment "A" hereto by increasing the appropriation for the existing project entitled "Mansfield Bridge Rehabilitation in the amount of \$907,000, from \$14,780,000 to \$15,777,000. The additional funding was provided by the PA Department of Transportation as set forth in Attachment "A."

No increase in County bond funds will be required.

#### SECTION 3. <u>Line Item Detail Amendment.</u>

The line item detail of the appropriations previously approved by Council shall be amended as reflected in Attachment "A" hereto, the provisions of which are incorporated by reference in their entirety herein.

- SECTION 4. <u>Severability.</u> If any provision of this Resolution shall be determined to be unlawful, invalid, void or unenforceable, then that provision shall be considered severable from the remaining provisions of this Resolution which shall be in full force and effect.
- SECTION 5. <u>Repealer</u>. Any resolution or ordinance or part thereof conflicting with the provisions of this Resolution is hereby repealed so far as the same affects this Resolution.
