WHEREAS, Dr. Sorr joined Everett & Hurite Ophthalmic Association, located in Pittsburgh, Pennsylvania, as its first associate physician in 1975; and

WHEREAS, Dr. Sorr has a distinguished reputation as an expert in disorders of the retina and vitreous, and his concern for his patients has been demonstrated by his ability to

communicate complex clinical problems on a lay level; and

WHEREAS, Dr. Sorr will retire from Everett & Hurite Ophthalmic Association on April 30, 2015 after 40 years of dedicated service to his patients;
