WHEREAS, born in Lancaster, PA, **Commander Vollrath** enlisted in the United States Navy in January 1981. Upon completing training, he was assigned to the USS Constellation and deployed to the Western Pacific and Indian Ocean in August 1981; and

WHEREAS, in December 1988, *Commander Vollrath* was honorably discharged from the Navy and was given the following distinguished awards: the Sea Service Deployment ribbon (2nd Award), Meritorious Unit Commendation, Navy Expeditionary Medal, Good Conduct Medal (2nd Award) Navy Expert Pistol Medal, Navy Expert Rifle Medal, Coast Guard Meritorious Unit Commendation with the "O" device signifying operations for actions conducted off Central and South America in support of drug interdiction operations; and

WHEREAS, for the last 25 years, *Commander Vollrath* has been employed by the County of Lancaster as a Correctional Sergeant at the Lancaster County Prison. He is married to his wife, Valerie, and together they have two daughters and two granddaughters; and

WHEREAS; **Commander Vollrath** has held numerous potions within the American Legion before becoming The Department Commander, those positions include: Post Sgt-At-Arms, Post Adjutant, District commander, Post commander, Eastern Section vice Commander, and serving on numerous Department and National committees;
