Motion of the Council of Allegheny County authorizing the Council of Allegheny County to conduct a public hearing, pursuant to Article II.G. of the Rules of Allegheny County Council on April 28, 2021, beginning at 5:00 p.m. in the Allegheny County Courthouse Gold Room, located at 436 Grant Street in Pittsburgh, PA. The Council President shall designate a presiding officer for such public hearing.

The primary purpose of this hearing is to allow the opportunity for public comment regarding Bill No. 11762-21, an ordinance amending the Allegheny County Code of Ordinances through the establishment of a new Division 9 entitled "Conduct" and a new Chapter 905 entitled "Independent Police Review Board" to establish an independent citizen board to receive and review allegations of misconduct filed by members of the public against police officers within Allegheny County..

Individuals wishing to speak must register in advance in accordance with the rules governing public comment at Council meetings. Written testimony will be accepted through 5:00 p.m. on April 30, 2021.

Council shall comply with the public notice requirements of Article II.G. of the Rules of Allegheny County Council. Council Members Nicholas Futules, Sam DeMarco, and Cindy Kirk have made commitments to attend the hearing.
