Proclamation recognizing and thanking **Mary Frances Cooper** for her dedication to the Carnegie Library of Pittsburgh, and we recognize her upon her retirement as President and Director of the Carnegie Library of Pittsburgh.

**WHEREAS**, **Mary Frances Cooper** joined Carnegie Library of Pittsburgh (CLP) as Deputy Director in 2008 and was appointed President & Director in 2012; and

**WHEREAS**, over CLP's 125-year history, **Ms. Cooper** is only the 11<sup>th</sup> person to serve in the position; and

**WHEREAS**, during her 13-year tenure with CLP, **Ms. Cooper** led several efforts to secure new sources of sustainable funding for the Library and worked to strengthen relationships with key community partners; and

**WHEREAS**, in 2011, **Ms. Cooper** collaborated with community advocates to help propel the special Library voter initiative, *Our Library, Our Future*, to success, resulting in a new dedicated source of operating funding for CLP; and

**WHEREAS**, **Ms. Cooper** led various service innovations at CLP, including the creation of the Office of Programs & Partnerships and the Office of Digital Strategy & Technology Integration; and

**WHEREAS**, under her direction, CLP completed the renovation, replacement or relocation of 10 CLP library branches, including the construction of the first certified Passive House library in North America (CLP-Carrick); and

**WHEREAS**, **Ms. Cooper**, along with leadership at the Allegheny County Library Association (ACLA), initiated a county-wide process in 2014 to consider the structure and funding of 21<sup>st</sup> century library services in Pittsburgh and Allegheny County, which has led to additional collaborative efforts among all county libraries, including the annual *Love Your Library* fundraising campaign, which has raised over \$5.4 million for all libraries in Allegheny County since 2016; and

**WHEREAS**, when the COVID-19 pandemic forced CLP to temporarily close its libraries in March 2020, **Ms. Cooper** guided efforts to ensure the public's continued access to library services, including curbside services, expansion of CLP's virtual programming and electronic offerings, and lending of wi-fi hotspots and laptops; and

**WHEREAS**, **Ms. Cooper** has served in all facets of library service during her 40-plus year career in public libraries, almost exclusively with urban public libraries across the nation, including Providence Public Library (RI); Worcester Public Library (MA); Minneapolis Public Library (MN); Louisville Free Public Library (KY); New York Public Library (NY); and Carnegie Library of Pittsburgh (PA); and

**WHEREAS**, **Ms. Cooper** is retiring from CLP in December 2021, culminating a distinguished career in library service and dedication to the people and communities that libraries serve;

**NOW, THEREFORE BE IT RESOLVED** that I, Allegheny County Council Member At-Large Sam DeMarco do hereby recognize and thank **Mary Frances Cooper** for her dedication to the Carnegie Library of Pittsburgh, and we recognize her upon her retirement as President and Director of the Carnegie Library of Pittsburgh.
